



Consignment Contract

WELCOME! We are excited to have you as a consignor! Please read these terms, if you are interested in consigning with us fill this out, contact us for an appointment, and bring this with your items.

Clothing:

- Only requested seasonal items accepted. (Be sure to check website or store).
- Is limited to no more than 20 items a week. If you wish to bring more than 20 items please contact us so we can make arrangements.
- Is to be freshly laundered and folded. (In boxes or totes. No plastic bags.)
 - Boxes & totes will be returned
- Is to have minimal stains or tears, and in good condition.
- NO – underwear, bras, or socks for older kids.

Toys/Equipment/Accessories:

- Check website or store for accepted items.
- Must have all parts and hardware and be in good working order.
- Any items requiring batteries must have working batteries.
- Must be cleaned and disinfected.
- Must meet all safety standards and have been checked for recalls. (www.cpsc.gov)

(If we check recall list & your items are on them, they will be returned to you and you will be charged \$2.00 per item) If this happens on more than one occasion, we will not accept items from you.

Furniture:

- Check website or store for accepted items.
- Must be clean and good condition.
- Must be assembled, have all hardware.
- Must meet all safety standards and be checked for recalls. (www.cpsc.gov)

(If we check recall list & your items are on them, they will be returned to you and you will be charged \$2.00 per item) If this happens on more than one occasion, we will not accept items from you. We may be able to pick up, there may or may not be a fee (Assessed per case).

(Any items that don't meet the above criteria, the consignor will be contacted and must pick up within four (4) days or the items will be donated or disposed of at our discretion.)

Be sure to check CPSIA website for recalls. As of August 14, 2008 it became unlawful to sell recalled products.

- Consignors will receive 40% of the selling price. Tots-N-More keeps 55%, with 5% going to local charities in Henderson and to Alex & Jenny Stewart who are missionaries in the Netherlands.
- When shoppers purchase an item with a credit card, 2% will be taken from the consignor's portion to help cover the credit card fees.
- Consignor ensures that items are the sole property of the consignor and that all information about these items true and correct to the best of your ability. If consignor is acting for someone else, then items should be listed as a new consignor.
- Consignor agrees that items will be priced by the store, held for 90 days, and may be discounted at the discretion of Tots-N-More. Items may be priced by the consignor when using the Price Guide.
- Consignor agrees that any items not sold by the end of consigned period can be picked up within five (5) days by request or will be removed from floor at end of season and stored by Tots-N-More.
Consignor must notify Tots-N-More of changes to e-mail address, Street Address, & phone numbers so that we may contact them.
- Tots-N-More will pay consignors quarterly by check as long as more than \$10.00, or can be kept on account for store credit to be used at any time. **Any unclaimed monies after one full year from the last account activity will automatically become property of Tots-N-More.**
- Tots-N-More will do their best to take care of your items but will not be responsible for fire, theft, or damage to your merchandise; no money will be paid for these items. Consignor agrees to make no claims against Tots-N-More or anyone with connection to Tots-N-More for loss, fire, theft, or damage, or any other cause.
- Consignor agrees to pay a one-time administrative fee of \$5.00 which will be taken out of first check.
- If consignor wishes to close their account or pull items before end of consign period, they may do so anytime with a two (2) day written notification, allowing five (5) days for Tots-N-More to pull items from floor & remove from computer system. Consignor will be responsible to pay a \$.50 per item stocking and storage fee at time of pick up. Any unsold items will be ready for pickup seven (7) days after notification.
